#### 2) STANDING COMMITTEE REPORTS

- a) Finance Committee
- Monthly Bank Reconciliation & Reports- April 2023- Jason Warner recommended that the board approve the Monthly Bank Reconciliation & Reports.

- iii) Fiscal Officer Annual Review & Salary Review Discussion-Fiscal Officer Johanna Gladman earned a stellar review. The new salary of \$132, 219.98 begins July 1, 2023, a 6% increase. The board commended Gladman for her work.

#### 3) FINANCE ITEMS

a) Fiscal Year 2023 Appropriations Revision No. 3-Johanna Gladman told the board the revisions are needed in order to have the most updated information for the Five Year Forecast. Gladman noted payment for FY 21 Medicaid in schools is now delayed. Overall, the projected cash amount shows a \$10,800 improvement.

b) Five Year Forecast-Fiscal Officer Gladman told the board the Five Year Forecast is required by the state, and intended to see any upcoming big changes as well as avoid major financial issues. She noted the difficulty of projections, based on ever-changing FTE (Full Time Enrollment) and that no state budget bill had passed yet. Assumptions used in the development of the estimates for each fiscal year help the reader of the forecast understand specific line items. All five years of the forecast end with a positive cash balance.

4) SUPERINTENDENT CONTRACT REVIEW OF PREVIOUS ACTION AND SLARY

- Monthly Residency Verification Update-Superintendent Heather Kronewetter told the board all verifications are valid.

- c) Resolution for Additional Personal Day- Superintendent Heather Kronewetter told the board that the amount of personal days for staff excluding the Superintendent and Fiscal Officer is increased from two to three days. The personal days are "use or lose" and are offered in support of staff in light of budget constraints.

d) Resolution for Staff Bonuses- Superintendent Heather Kronewetter told the board that the one-time bonuses are paid through ARP ESSR grant money. Teachers that commit to remain employed for the 23-24 school year will receive \$5000. Aides that commit to remain employed for the 23-24 school year will receive \$3000. The EMIS coordinator will receive \$2000. HR/Payroll will receive \$1000.

e) Resolution for Peace Officer Training- Superintendent Heather Kronewetter told the board that the Peace Officer interaction curriculum is mandated by the ODE due to a new law.
