3) ADMINISTRATION ITEMS AND UPDATES

a) Monthly Residency Verification Update-September 2023 Superintendent Heather Kronewetter told the board that all verifications are valid. Annual verifications continue.

b) One Plan/School Improvement Plan Update

Superintendent Heather Kronewetter told the board that corrections to the Plan were made to match the state's updated template. Goals show progress. She noted that graduation requirements continue to conflict with students that are legally allowed and choose to stay at OCS through their 22nd birthday.

c) Local Report Card Results

Superintendent Heather Kronewetter told the board that the Report Card shows 2 1/2 stars out of 5, which is positive considering OCS is 100% IEP and the Report Card does not fully reflect OCS success. Strengths and progress include growth of all OCS students and GAP closing. She noted the graduation rate fluctuates based on students needs, and the Early Literacy rate because OCS students may or may not be alternately assessed.
